Bella is a precocious toddler who loves to dance. In 2018, tests in India revealed a mass on her brain. Bella's parents turned to St. Jude Children's Research Hospital for her care.

At St. Jude, Bella's treatment for anaplastic ependymoma, a cancerous brain tumor, included proton therapy and chemotherapy. "At St. Jude, they're not just thinking of your child's treatment, they're thinking about what families go through," said Bella's dad. "You don't have to worry about anything. You just focus on your child."

Bella is now home and returns to St. Jude for regular checkups.
