Qualifications:	 Adult family member of a deceased child who has been a patient at St. Jude Children's Research Hospital

	 Must be at least two years from the anniversary of the child's death and at the discretion of the Bereavement Coordinator 	
	 Commitment of 1 year in Lead Parent Role per the Bereavement Coordinator's discretion. 	
Training:	Successful completion of primary Volunteer Services/FCC orientation, PAIR MENTOR training and advanced bereavement training as deemed appropriate by the Bereavement Coordinator. Completes annual FCC and volunteer training.	
Competencies:	 Exceptional verbal, written, interpersonal skills, and emotional maturity necessary for project development and implementation as well as parent education and serving as a parent panelist

- Serves at the OQL Steering Committee parent representative on the DOR planning committee and is available for monthly meetings by teleconference
- Serves as the QOL parent representative on the PAIR Mentor steering council and is available for monthly meetings by teleconference
- Collaborates with the Bereavement Coordinator on special projects, strategic planning and parent roles during staff educational programs
- Ongoing update of resources in bereavement library in conjunction with the Bereavement Coordinator and psychosocial team
- Assists the Bereavement Coordinator with leading the scenario discussions related to grief and bereavement during the second day of the PAIR Mentor training.
- Serves as the on-site FCC QOL resource for families and staff
- Serves as a liaison to the Family Advisory Council and other family centered care committees or councils. Assists the Bereavement Coordinator with providing updates on the QOL Steering Committee activities as the monthly FAC meeting.
- Assists the Bereavement Coordinator with quarterly debriefing sessions with bereaved parent mentors
- Assists the Bereavement Coordinator in the recruitment of bereavement parent mentors by calling and conducting initial screening of Bereavement parent mentors, where appropriate.
